#### **Position Summary**

We are seeking a highly skilled and compassionate **Psychiatric Registered Nurse (RN)** to serve as our **Nurse Manager**. This leadership role oversees clinical operations, supervises direct care staff, ensures compliance with Washington Administrative Code (WAC 388-107 & 388-112), and plays a vital role in guiding our trauma-informed, person-centered, and recovery-oriented environment. The RN Nurse Manager will lead nursing efforts to ensure safe, therapeutic, and holistic care for residents with behavioral health diagnoses.

### **Key Responsibilities**

#### **Clinical Leadership & Oversight**

- Supervise and support all nursing and care staff, including Licensed Practical Nurses (LPNs) and Psychiatric Care Aides.
- Provide clinical leadership in medication administration, assessments, documentation, and infection control.
- Develop and oversee implementation of **Individualized Service Plans (ISPs)** in collaboration with interdisciplinary teams.
- Lead daily shift reports, case reviews, and participate in care planning and discharge planning meetings.

#### **Behavioral Health & Psychiatric Nursing Duties**

- Monitor and manage behavioral health symptoms through psychiatric nursing principles.
- Respond to psychiatric emergencies and guide de-escalation and crisis intervention in coordination with mental health professionals.
